Office report for BOD meeting, November 11, 2014

1. Membership

There are membership applications coming in for 2015 renewals and new memberships. I would like to send an email blast to remind everyone to renew now and be prepared for the 2015 show season.

2). Shows

Results from every ALSA show in 2014 have been accounted for. Most of the results and fees from these 2014 ALSA shows have been collected. The posting of the shows were halted due to the preparation of the 2014 GN. The postings have resumed.

3). 2014 Certificates being worked on.

I would like to send an email blast to everyone to mention that if they have not received a certificate for their animal, youth, or adult showmanship for 2014, to please let the office know so the research can be done.

Might be prudent to wait until December. This will be enough time after the NAILE for members to begin thinking about researching.

Dear BOD -I have a change in a Handbook Rule that I would like to address. The rule is found in the 18th Edition ALSA HB, Part G., Section 6, page 36

Section 6. Recording Fees

- A. The one time recording fee per llama is \$20. During the year that the recording fee is paid, a person may request the ALSA Office to research all show results for the current calendar year and accumulate points tor that animal.
- B. There will be a \$25.00 per animal per year fee for accumulating points on the animal in any year or years prior to the year the recording fee was paid. This is possible with the 2002 show season. There will be a \$25.00 per animal per show fee to research show results prior to the 2002 show season.
- C. Recording forms, change of ownership forms, and animal name change forms are available from the ALSA Office.
- D. All llamas previously recorded with ALSA for point accumulation do not have to pay another recording fee.

From my conversations with people, <mark>I would like to address B.</mark>

I do agree that there needs to be a charge to accumulate "back" points, however, it seems rather steep to charge <u>\$25.00 PER YEAR</u> for "back" points.

When people are getting an ALSA tracking number and they ask about getting their "back points" and they are made aware of this charge, they tend to not get any "back" points. In my opinion this hurts the ALSA award system with the chances being so small now to get points. It seems that people do not mind a one-time fee of \$25.00 and will gladly pay that.

Now, I do not think it is fair that others get an ALSA tracking number before a show and ones that do not get a number may "*REAP THE BENEFITS SO TO SPEAK"*, but the NA# animals pay the \$5.00 fee too. Even with this said I do think a fee needs to be in place. But I think this charge needs to be reduced.

I am able to find results in the system under the NA number. It is not difficult to find and change them all to the new ALSA Tracking number and award the points.

Yes, each year must be researched separately, and Yes, it requires looking into the database, and YES it did take a little more time in the beginning to post results since they did not have an ALSA tracking number and must be assigned an NA number or have one looked up, but once the NA number (or numbers) is located for this animal, it is not difficult. The time will generally be according to the amount of shows if there is a Grand or Reserve involved and points must be awarded for the division.

I would like to add this to the BOD meeting agenda next week, Nov. 11, 2014.

2014 ALSA Director Recall Petition

Results - October 29, 2014

ARTICLE IV - Election, Section 1: Election (i) A Director may be subject to a recall vote by a signed petition of at least twenty five percent (25%) of the membership who were members in good standing as of the Day of Record,.....

A Petition to recall two Directors was circulated. Petitions were to be received by the ALSA Election Committee no later than October 28, 2014. Petitions were to be delivered to the Election Committee by USPS mail or e-mail.

The 2014 ALSA Day of Record was April 1, 2014. As of that date the number of members in good standing was 305.

To successfully recall the two Directors, 77 Petitions must have been received by the Election Committee by the deadline.

The Election Committee certifies 37 Petitions were received. Nine of the 37 Petitions could not be validated as signed by members in good standing as of the Day of Record (April 1, 2014).

Therefore, the Election Committee reports the Petitioning process to recall two ALSA Directors has failed.

Subject: GRAND NATIONALS RECAP.

Kansas Facility was very nice. Lots of room in the arena for the classes. Large vendor area, as we had 4 more vendors this year, over last year. We have room to add more stalls as we continue to grow. Deposit money has been sent to hold facility for next years show, weekend of Oct. 22 thru 25th, 2015.

We increased our number of classes from aprox 450 to over 600. Increases and decreases were as follows. Halter up 10 Performance up 10 Fleece down 5 youth up 135 from 135 total 274 youth classes sub junior up 5 from 5 to 10

Banquet and awards were very nice. Over 160 exhibitors attended, and there was plenty of food and seating for all.

Grands and reserves were awarded for Youth, Performance and Fleece Awards during the awards ceremony.

We came in under budget on Ribbons of aprox. \$300, trophies by aprox. \$25, and Programs by aprox. \$400.

The only negative, which is also a positive, we heard from the judges was that they were very long days, and would recommend to us we add at least another half show day, as our entries continue to increase.

There have been multiple farms and ranches posting and displaying their awards and placings on social media, showing their contentment with the show, ribbons and trophies.

10-21-14 Dear ALSA Board of Directors:

Ken Forester as chair of the Judges' Committee received a formal complaint from Larry Lewellyn. The complaint was against Ken Forester and is attached. As soon as he received the complaint Ken forwarded the complaint to the committee, excused himself from the Judges' Committee for this issue only and charged me with spearheading the issue with the rest of the committee.

In a unanimous decision the Judges' Committee reached the following conclusions.

1. Reading the purpose of the Judges' Committee on page 6 of the handbook. (Section 2, H) the Judges' Committee has concluded that this issue does not appear to be a function of the Judges' Committee.

2. The standing rules for judges on page 130 of the handbook (Part S, section 4) along with Part T, section 4 A in the ethics section are quoted in the complaint. This complaint appears to be about something that happened within the BOD between Ken as President and the BOD. The Judges' Committee concluded that it had nothing to do with anyone outside of the ALSA Board of Directors and certainly nothing to do with the Judges' Committee.

3. This complaint looks to be really about whether or not Ken Forester should be chair of the Judges' Committee. That is a BOD function, not a Judges' Committee function and the committee understands he has been approved as chair by the current BOD.

4. It is the Judges' Committees unanimous opinion that acting on this complain is not within the defined purpose of the Judges' Committee but is really a BOD issue and that the complaint should be forwarded to the BOD.

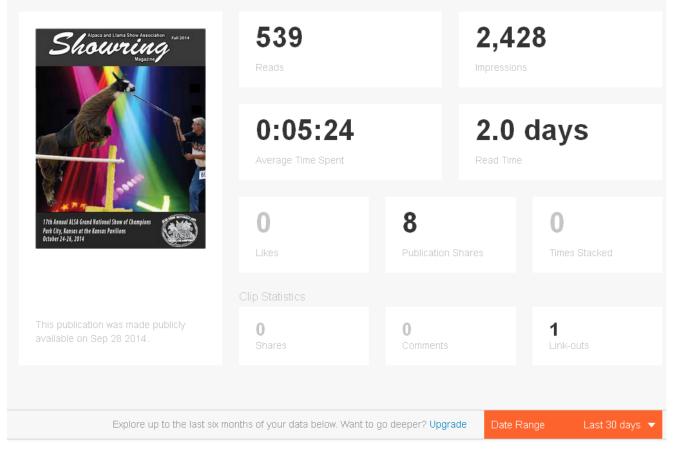
