### **Office Report**

BOD Meeting - Office Report Tuesday, January 9, 2018

### 1. Memberships

### 2. Shows

As of today, January 4<sup>th</sup> 2018 we have one 2017 show that we have not gotten the results for. This show is the 2017 Indiana State Fair Llama & Alpaca Show held in Indianapolis IN on August 4-5, 2017. This is being attended to. The "TOP 10 YOUTH AWARD" cannot be calculated until the final results are received. All shows, except for the above mentioned show, are posted for 2017.

There are currently 14 shows on the ALSA calendar for 2018. There will be some email blasts going out to remind all superintendents to get their shows on the calendar now for 2018.

Motion by Larry to accept Treasurer's Report, seconded by Bill. Debbie votes yes. Cheryl abstains.

Cheryl will send Board members a two-year Profit and Loss Comparison Report for review and budget planning.

**Old Business:** Draft letter to member regarding marketing idea was approved to be sent.

**New Business:** Treasurer – Discussion regarding the transition of responsibilities when the new Board members are elected. The selection of the next Treasurer will be decided by the incoming Board and Cheryl will do everything possible to make a smooth transition and make sure ALSA financial matters will continue to be taken care of. It was noted that the Bylaws do not require the Treasurer to be a member of the Board of Directors. There has been some confusion about this point and it was suggested that the Standing Rules be amended to clarify that the Board can appoint or hire a person to perform the duties of Treasurer if no elected Board member is willing or able to do so.

Youth Jamboree – Larry has had conversations with Mark Foerder and Marilyn Nenni regarding the Youth Jamboree to be held in July and possible incentives to increase ALSA youth membership. He will get a specific written proposal for Board review.

Proposed Youth Event in March in Southeast Region -- Bill had a conversation with Cheryl Lambert about possibly teaching a youth seminar at the SSLA Conference. He will get more information from Cheryl Lambert and request approval from the Judges Committee.

## **Correspondence from Members:**

This request is being made on behalf of the Grand Mesa Llama and Alpaca Club. The Club has hosted the Grand Mesa and Kokopelli Llama Shows in Grand Junction for many years. As the llama community has gotten smaller, so have our shows and we operate on a very tight budget.

In May 2017 we were forced to cancel our shows at the last minute due to an unusual late snow storm which made it dangerous and almost impossible for exhibitors to travel across the mountains to get to Grand Junction. It just wasn't worth people risking their lives and animals for a llama show.

In fairness to the exhibitors we refunded all entry fees. Unfortunately the airlines, hotels and Mesa County Fairgrounds were not as generous so we ended up paying for many expenses without any income to cover them. I am therefore requesting that the \$75 of sanctioning fees that were paid to ALSA for the 2017 shows be applied to the 2018 Grand Mesa and Kokopelli Llama Shows. Please let me know if this will be possible. Thank you.

Ethics Committee - Chair: Cheryl Lambert – Liaison: Cheryl – No written report. Goal is to have a code of conduct drafted for next Handbook revisions. The Committee Chair

informed the Liaison that she has received calls from members wishing to file ethics complaints about an exhibitor entering unqualified animals in Master Performance classes just to fill the division so her Grand and Reserve placings would count towards the ALSA Awards Program. Larry stated that the show superintendent who allowed this was also to blame and that members who feel a rule has been violated should not hesitate to submit written complaints.

Fleece Committee - Chair: Open – Liaison: Cheryl – No response was received from one of the people who was asked to serve as co-chair and we need to get a chair in place so the Committee can get to work.

Here is an option for an alternative to attending the Grand National Judge's Meeting in person. We had such good participation at this one in 2017 using the webinar approach that I think we could do alot more with it.

Part S – Section 2 A9

9. All ALSA judges who meet the following requirements are released from having to attend any further clinics:

a) All dues are current.

b) All required paper work is current.

c) No upheld complaints or protests.

d) Judge must attend participate in at least one Judges' Video conference meeting held at the Grand National in a 5 year period. Participation may be in person, by phone or via web conference.

e) Judge must participate on a yearly conference call as conducted by the Judge's committee.

Larry,

I am seeking approval to research some ideas for ALSA incentives and I'd like to let the ALSA BOD be aware that I am willing to promote ALSA through the Publication and Promotions Committee by using my marketing abilities. I feel this will help ALSA with increasing its membership, Show attendance, Regional Shows, Grand National Show, and other sponsored events. My first idea for consideration is this:

Each month have a PHOTO OF THE MONTH contest. Entries MUST BE from an ALSA member. (This will bring membership)

This will be open to all Adult and Youth together. (Only one award per month given)

Only one entry (photo) per individual per month. Each month the winner will be voted on by me by the first week of the next month. The three most current photos will be picked for the cover of the Showring Magazine. (The Showring is a quarterly magazine, so it is published every 3 months and I would choose between the last 3 winning photos for the cover.)

If their photo is chosen for the front cover of the Showring, they will be entitled two Free ALSA numbers. (This is non-transferrable)

All the winning photos will be published in the Showring and on the ALSA website with them and their ranch recognition.

This idea is open for suggestions. I would like to start on this right away for January!
