ALSA Board of Directors Meeting November 13, 2018

I. Office Manager's Report:

BOD Meeting - Office Report Tuesday, November 13, 2018

1. Memberships

There are a few membership renewals coming in for 2019. There will be some email blasts going out to remind all to renew now for 2019. *Incentive?*

2. Shows

There are shows being sanctioned now and put on the calendar for 2019. There will be some email blasts going out to remind all superintendents to get their shows on the calendar now for 2019.

3. Goals of Office for November and December 2018:

The primary goal of the ALSA office is finish posting all remaining shows for 2018. After posting, the youth top 10 can be figured and posted.

Motion: To accept the Office Manager's report as presented. Motion by Ron. Seconded by Carol. Motion unanimously passed.

Robin left the conference call at 7:13 p.m.

II. Treasurer's Report:

Vern presented a financial report for November, with emphasis on results of the Grand National (all of which are not yet in). Considering attendance, the opinion generally was that expenses were too high compared to revenues. Regional revenues could be higher than last year, although all the expenses and revenues are not yet in. A lengthy discussion was taken regarding ALSA office expenses and what to do about them. Last year's Board committed ALSA to a two-year contract with the office manager. This is the most significant expense that ALSA incurs and steps need to be taken to curtail it. The Treasurer's complete financial reports are presented at the end of these Minutes.

Vern left the conference call at 7:51 p.m.

III. Old Business:

A. Grand National Show

Discuss and wrap up the 2018 show. Begin discussing changes for 2019. Arena rental expenses were greater than in 2018 and one suggestion is to seek a new venue for the show. Other ideas were discussed regarding the future of this show, now in its 21th year. There will have to be certain significant changes to the show format in the future in an effort to curb expenses and increase attendance.

IV. New Business:

A. Website problems. The following email from Deb should get us started: When we ran the websites (there is an <u>alsashow.net</u> and <u>alsashow.org</u> site) through our website check software we found a variety of things. The websites have 126 and 123 pages and 705 and 332 PDFs respectively. There are also over 200 broken links and 62 redirected links. All that to say the sites are in dire need of a comprehensive organization and cleanup. We honestly think it would be best to start fresh and bring over the important aspects of the existing websites.

That being said, this is going to be a big undertaking. Not to just organize everything and make a plan for the new website, but also to build the new website. Given the time, meetings, and work involved, I estimate we would be around \$1,275 for the cleanup and organization and around \$4250 in the build out.

The only other option that I mentioned above, would be to scrap the existing websites and build an entirely new website based on a couple of meetings with the decision makers to discuss what the site needs. We would only reference back to the existing website for content details and relevant information. Doing so would eliminate the organization step/costs and I estimate the buildout for roughly 10-12 pages would be approximately \$3825. If we determined we needed additional pages or functionality we could build those pieces at our hourly rate.

This item was tabled due to its cost in view of ALSA's financial condition. Alternatives are being investigated.

- **B.** Bylaws and Standing Rules revisions. Please see the report of this committee below. Actions need to be taken as regards the items therein mentioned and will be discussed under that committee report.
- **C.** Treasurer's responsibility. Presently, all responsibility for payment of invoices rests with Vern, who is not a Board member. This places him in an awkward position to say the least. A past Board allowed payments for under \$1,500 and recurring payments to be made without Board review and scrutiny. This well could be a contributing factor to the current financial condition of ALSA.

Ron suggests that the Finance Committee, at the least, ought to review and approve every expenditure BEFORE it is paid, preferably before it is made. At least one member of the Board should be on the Finance Committee. Ideally, the Board

should be provided a list of ALL payables to review, BEFORE they are paid so they may be questioned and examined for ways they can be either eliminated or reduced to be more economic in running ALSA and preserving the cash on hand.

Motion: The Finance Committee should review all contracts before they are signed. Lists of payables need to be reviewed by the Finance Committee for their pertinence and applicability to the ALSA Mission. The ALSA office is to submit line-item expenses in a timely fashion for review before they are paid. Motion by: Deb. Seconded by Lauren. Motion unanimously passed.

Vern noted the ALSA office has not submitted expenses for three months.

D. The Election Committee has recommended the following suggestions to the election and other aspects of the Bylaws and associated Standing Rules to facilitate Boards taking office earlier than the current July 1st date:

Conduct a Bylaws ballot in the first quarter of 2019 to modify the election process with wording similar to: the election process begins with the Day of Record at September 1st, allowing members who join during the show season to announce their candidacy and or vote. Election voting would be approximately October 1st and end October 15th with results announced shortly thereafter. New Board members would be able to participate as non-voting members of the Board in November and December, to become familiar with items, and officially take office January 1st.

Since two current Board members leave office June 30, for 2019, the outgoing President becomes Past President and attends Board meetings in an advisory non-voting capacity. In future years, the out-going President remains on the Board until the next election as Past President, a non-voting advisory position.

It has come to the attention of this Committee that in the fall of 2017 the Board approved two changes to the Standing Rules then in effect. While approved, the changes were not physically incorporated into the Standing Rules at that time. They may be seen in red below.

Please review and either accept these changes as written a year ago or edit each the way this Board wants them to read.

- 1. This is a new item added to Article I Section BOD Conduct
- (c) BOD members are subject to the Ethics provisions in Part U of the ALSA Handbook and have a duty to follow and uphold all provisions of the Handbook.

MOTION: Approve as written and may be added to the current Standing Rules. Motion by Ron. Seconded by Cathie. Motion unanimously passed.

- 2. These are words added to Article II Financials. Section I (b)
- (b) All checks in the amount of \$1500 or over must be approved by the BOD prior to signing. This restriction shall not apply to payments due which comply with the written terms of a contract that has been approved by the Board pursuant to a motion and vote duly recorded in the official Board minutes.

This addition to the Standing Rules was not approved, due to the action taken under IV. C. above, which will be added to the Standing Rules.

Thank you for your attention to this. The Standing Rules will be updated after your consideration.

A Bylaw revision proposal and plan to move the Director Election from May to October was requested and presented to the Board at its meeting in Hutchinson KS. The reason for the change is to have new Board in place at the beginning of the year rather than half way through the year. It will have the previous year's financial records to use to budget and plan for the coming show season. Committee Chairs will be confirmed at the beginning of the year and be able to submit their budgets as well.

The Board reviewed the bylaw ballot process and the Director's election timing. It was then presented to the general membership at the Annual Meeting and met with positive comments. This is the tentative schedule that was presented.

First Quarter 2019- Bylaw revision ballot to change Director's Election to October. Day of Record set for mid-February. Voting to be completed by mid-March.

Second Quarter2019 – Two Directors complete their three-year term June 30. Five Directors remain on Board.

Third Quarter 2019– Mid-July Call for Candidates. Day of Record set for Sept 1. Candidates write their Statement. Electronic voting set up.

Fourth Quarter 2019 – Director Election voting during the first two weeks of October, dates to be set later. Third week in October winners and alternates announced. Directors elected may attend November and December Board meeting as non-voting attendees.

First Quarter 2020 – New Directors take office January 1. Board returns to 7 members. New Board has all financial information to budget and will also be able to confirm Committee chairs at beginning of year.

The discussion of this meeting centered on where will llama/alpaca judges be in 20 years.

Shows have become smaller while at the same time marketing of llama and alpaca related items in the retail industry has taken off. How can we as judges take advantage of this increasing interest?

Suggestions ranged from open ranch days, play days and educational seminars. But an understanding of the demographics of the llama/alpacas market is needed. Many areas no longer have ranches available to board llamas/alpacas. So even though we have interest, many of the people interested have no place to physically have any lamas.

Part of the discussion also touched on veterinary requirements for some shows and states. In some areas it is becoming more difficult for shows to operate due to the requirements placed on lamas by the state vet. A possible solution would be for one organization to spearhead a medical advisory committee that would have a member from each of the many lama organizations from around the country. This committee would then be able to work as a unit to help many of the state vets to understand lamas in a more realistic light.

Tor brought up though how some areas are just not suited for the raising of lamas. The area in the Southwestern US that is prone to Valley Fever is not a viable area for lamas to be raised. Lamas can develop and succumb to Valley Fever.

It was a very productive group discussion and hopefully it can continue on with not just the judges but with ALSA members as well. If we are to have shows for our newer ALSA judges to judge in 20 years then now is the time to begin working on solutions and options.
