This Alpaca Judges Clinic is open to ALSA members interested in Beginning Alpaca Halter Judging or Advanced Alpaca Halter Judging, as well as those needing to re-certify as an Alpaca Halter Judge. The clinic will cover two and one half intense days of instruction, judging, and testing in two parts. The first part of the clinic will cover criteria for evaluating both Suri and Huacaya fiber, terminology, evaluation process, placement, and the Alpaca fleece judging card criteria. The second half will cover alpaca conformation, anatomy, phenotype, defects and movement. Participants are expected to successfully complete the minimum requirements in both areas of the program for certification.
