We received information from Deb Yeagle about the status of the following people who attended the November, Texas Clinic:

1. The Judge's Committee is recommending that Terese Evenson receive certification to judge alpaca and llama fleece. She has completed the required clinics with high marks and has done her apprenticeships. She has also been an ILR Fleece Judge for some time.

- 2. Doug Bearmar is recommended to begin his apprenticeships in Ilama halter, performance and youth. He performed very well at the clinic according to Deb. He also very actively breeds and shows Ilamas. This experience will help him with ring management.
- 3. Lisa Rice is being recommended to begin apprenticing in Ilama halter, performance and youth. It has been a very long time since she initially started working with the Judging Program therefore she will need to complete the 3 Apprenticeships and the Final Clinic. She attended the fleece portion of the clinic but has not paid for it, so we are withholding recommendation for apprenticeship in this area until she has communicated her intentions.
- 4. Adryce Mathisen attended the Clinic to add to discussion, assist and practice skills due to the proximity to her home..

The Clinic was graciously hosted and supported by Susan Leslie. Susan's daughter, Ana, assisted along with Bill Feick.

When I received Deb Yeagle's November Clinic Report I noticed that Linda Tinsley and Susan Leslie did apprenticeships in Ilama and alpaca fleece at the clinic. Due to the fact that the Handbook states: Part S Section 4B: 3. An Apprentice may not apprentice or exhibit animals while attending a Judging Clinic. (See exception, Part C, Section 1-E) the Committee is unable to accept the Apprenticeships.

If Deb wishes Susan and Linda to receive credit for the apprenticeships, she will need to submit the required documentation and petition the Board for a waiver of the rule.

#### IV. New Business:

- **A.** The Tinsleys, who have graciously offered to pick up all ALSA assets currently in the hands of the office want a list of the assets to be transported. That list does appear in the November 20<sup>th</sup> Minutes. They are to purchases boxes for the assets, for which ALSA will reimburse them. They must contact Robin and set up a mutually satisfactory date for the process. They will verify that all passwords and so forth work after they have secured computer and other data.
- **B.** There was discussion about a new location for the 2020 Grand National Show. Board members have contacted various locales and found some potentially suitable new locations. One very important item as regards, Grand National, there is concern about conflicting with any of the Regional shows.

The 3<sup>rd</sup> or 4<sup>th</sup> weekend of October still seems the best on which to have the Grand National Show. Travel times to the show are considered an important factor in its success. This is especially true for exhibitors who have youth involved in showing, since long travel times can mean school absences. While travel times from actively participating parts of the country have been determined for some locations, this is a factor that will continue to be monitored and considered in determining a new location.

Presently, the Ozark Empire Fairgrounds in Springfield, Missouri, the Iowa Equestrian Center and the National Equestrian Center in Lake St. Louis Missouri appear attractive.

There will be a Special Board meeting December 18, 2019 at 7:00 p.m. CST. The next regular Board meeting will be January 8, 2020 at 7:00 p.m. CST.
