
# Office Report:

### Linda:

- 1. I am getting shows put in as fast as I can! I worked 11 straight days and made quite a bit of progress. The results that are submitted via the new spreadsheet are a snap to get loaded onto the database, thus the website. The results that are emailed and are on a PDF form were proving to be problematic. I used the debit card and purchased from ADOBE software to convert PDF files to Excel files at a cost of \$1.99/month. This was a game changer and saved hours and hours of retyping everything, thus saving ALSA money. I verified animal numbers for 2 of Kathy Duval's double shows in less than two hours. And they were DONE! In contrast it took me 2 8-hour days to do one of Tami Lash's Millennium shows. One of the drawbacks I am hearing and utterly understand is that not everyone has access to Microsoft Excel. Personally, I would die without it, and we get it for a minor fee through Karl's employer. So, I get it; Microsoft office is expensive and who wants to pay that kind of money just for ALSA results. SO…between Karl and Becci I am convinced that Google Docs is the way to go. Once I get 2022 done, I will set 2023 up on Google Docs.
- 2. Anna brought up the "no animal name" on the youth results on the website. There is a column header for animal name, but our current results show this column as a blank. The BOD agreed in the December 2021 meeting to capture the animal number. This is more accurate than a name because as we have all seen names can change (i.e., Tiny Dancer, Pleasant Acres Tiny Dancer, Dancer, JJ, JJ Watts, J Wats) from show to show. In researching this situation further, I looked back to 2017 and lo and behold the animal's name was listed on the website results page. I questioned how this came about. In looking at the individual "Add youth points" recording record there is a field to manually type in the name of the animal, whereas when entering animal points, the animal number brings up the animal's name for verification.

Linda commented that she is making great progress getting shows entered. There are some problems with animal names and numbers.

The Board recommended she use only the ILR numbers for the animals when entering data.



The only way to have the animal's name show up on results is to enter each and every entry one by one as we did in the past. I can see if Karl cannot get that animal number to print in that column on the website for now. He is a bit reluctant to make such changes in our current website for fear of "breaking it." Once we move to a new website we can put the name, the number, the eye color, or the age of the animal.

#### Becci:

- 1. When can members start renewing for 2023? I had a new member contact me about paying for a new membership and it rolling over to 2023? Cathie and the Board agreed that if a member is renewing at this time of year, the membership is valid until the end of 2023.
- 2. Previously there was discussion about adding me to the email? I am just following up with this to see if this is still something the Board wants me to do. The Board definitely wants Becci added to the email, so she is cognizant of all inquiries.
  - 3. I would like to add Facebook to the ALSA phone, it would make it easier for me to answer messages and post information, especially when at shows and at Nationals. I would need additional information for the app account, I think billing address mainly. The Board approved Becci adding Facebook to the ALSA phone charges, so there is more exposure to ALSA and its activities.

Discussion related to the weekly telephone meetings Linda and Becci hold to discuss their work. For Board members to join this call, notify Linda beforehand for admission to the conversation.
