8. Judge's Committee: (liaison: Cathie)

The Judges Committee is asking the BOD to consider the following items for their approval:

1. Changing the Level judge system and Clinics

- 2. New CEC report for the Judges
- 3. Clinic instructors
- 4. Mentor Program
- 5. Past rule changes
- 1. With Ilama shows becoming smaller across the country the ALSA Judges' Committee have been reevaluating the current level system of ALSA Ilama judges. With many shows being less than 100 animals it is our proposal that at this time, ALSA removes the level system.

This will mean that upon satisfactory completion of an advanced clinic and approval by the Judges' Committee/ALSA BOD an apprentice will become a judge and enter the judge's pool. There will be restrictions in place as to requirements for judges to judge Regionals, Nationals or to accept apprentices.

It is our feelings that this will provide a fair and equitable system for all judges. Some smaller shows are hesitant to hire a current "Senior" judge due to the perceived cost for that judge and some small shows will hire only "Senior" judges. In both cases qualified judges are being overlooked.

Page 128, Part S, Section 1-A

Llama; Judges are certified to judge llama halter, performance and youth shows.

Trish motioned to approve Page 128, Part S, Section 1-A. Allen seconded. Motion carried.

Page 128, Part S ,Section 1-G

- . Apprentice Llama or Alpaca Judges may apprentice under an approved Judge who has been Judge for a period of five years from their advanced clinic.
- . Apprentices may not act as an Assistant Performance Judge during their first apprenticeship. An Apprentice Judge's opinion has no effect on the class placings unless they are working as an Assistant Performance Judge.

Allen motioned to approve page 128, Part S, Section 1-G. Trish seconded. Motion carried.

Page 129, Section 2, A-6-10-11

A-6 We would like this rule removed as this is a grey area and has not been used in years. This would remove any doubt of favoring one judge over another.

Tom motioned not to approve item A-6. Bob seconded. Motion carried.

A-10

Recertification - required every three years, may be accomplished by successfully completing an Advanced Judging Clinic followed by recommendation of the Judges' Committee and approval of the ALSA Board of Directors. Judges may also receive a recommendation to renew their certification through Continuing Education Credits if they have acquired at least 100 total credits at ALSA sanctioned shows and have no upheld protests in their file .This must be done by submitting the

required paperwork to the Judges' Committee and submitting to the entire recommendation procedure. Contact the Judges' Committee Chair for complete requirements.

Trish motioned to approve item A-10. Allen seconded. Motion carried.

A-11

Judges must successfully complete at least three llama show apprenticeships under at least three different ALSA approved Judges at ALSA sanctioned Shows with 75 or more llamas.

Allen motioned to approve item A-11. Trish seconded. Motion carried.

Page 130, Section 2, B-4-6-8

B-4 Must successfully complete at least three llama shows apprenticeships under at least, three different approved Llama Halter Judges at ALSA sanctioned shows with 75 or more llamas.

Allen motioned to Approve item B-4. Trish seconded. Motion carried.

B-6 Must successfully attend an Advanced Llama Halter clinic and obtain a minimum score of 85% in the Halter portion, 85% in the Performance portion, and over 85% composite score for the clinic and all requirements.

Trish motioned to approve item B-6. Allen seconded. Motion carried.

B-8 Approval of Regional, National and Apprentice accepting Llama Judges, including fully certified, Youth and Performance Judges, are defined as follows:

All Judges must be a Certified ALSA Judge for 5 years and judge three shows per year with 3 shows having 85 animals or more and three performance shows with 85 entries.

Tom motioned to approve with following wording.

Approval of Regional, National and Apprentice accepting Llama Judges, including fully certified Youth and Performance judges, are defined as follows:

All Judges must be a Certified ALSA Judge for 5 years and judge three shows per year with 5 shows in a 5 year period having 85 or more entries.

Bob seconded. Motion carried.

C-4 Any present Youth and/or Performance Judge certified under old ALSA rules wishing to upgrade their ALSA Judging license to include Youth Judging classes must successfully complete one apprenticeship with a Judge during Halter classes.

Must successfully complete one apprenticeship with an approved Judge during Youth Judging classes. These two apprenticeships may be completed at the same show. Must attend an Advanced Llama Judging Clinic.

Trish motioned to approve item C-4. Allen seconded. Motion carried.

Page 130 Part S. Section 2-B #10

10. Llama Judges that have meet the criteria established by the Judges' Committee to judge an ALSA Regional or National show or to accept apprentices will be designated on the official judges list by an asterisk beside their name.

Allen motioned to approve with following wording:

Lama Judges that have met the criteria established by the Judges' Committee to accept apprentices will be designated on the official judges list by an asterisk beside their name. Trish seconded. Motion Carried.

Note to committee: ALSA handbook as different requirements for National and Regional judges..

Page 133 Part S. Section 2-G- #10

10. Approval of designated Alpaca Halter and Performance Judges is defined as follows Junior Level Alpaca Judge, up to 125 alpacas; Senior Alpaca Judge over 125 alpacas. Any Judge may be hired to assist the Head Judge in Performance at a show with more animals than their allotted number. They may not, however, act as the sole judge for any of these classes.

Bob motioned to approve. Tom seconded. Motion carried.

Page 134 Section 4. A-4.5.7

A-4 Judges who do not pay their dues, both member and judge, by January I, will have their license suspended. If dues are not paid by February 1st , their license will be suspended for the calendar year.

A-5 Judges must audit a Judge's clinic at least once every ten years to be recertified by the Judges' Committee and Board of Directors. As long as they can recertify every three years with CEC reports.

(Judges are encouraged to attend additional clinics to further their education and stay current on Handbook changes.)

A-7 Only ALSA approved Llama and Alpaca Judges may accept apprentices at an ALSA Show with 75 or more animals. Llama and Alpaca Judges, may accept two Apprentices per single show with the approval of the Judges Committee. Llama and Alpaca Apprentices can complete their third apprenticeship at a double-judged show with 75 or more animals. The Judge is then responsible for the education and supervision of those Apprentices, following the written guidelines of the Judges' Committee. Written Apprentice evaluations must be returned to the committee chair within five (5) days after the show.

Bob motioned to approve page 134, Section 4 Items A-4, A-5, A-7, with effective date on Item A-4 of Jan 1, 2012. Cathie seconded. Motion carried.

Page 135 Section 4 B-3

An Apprentice must complete apprenticeships under at least Three different approved Llama or Alpaca Judges, as approved by the Judges Committee. One alpaca apprenticeship must be done with more than 75 alpacas shown.

Approved by BOD.

Page 136 Section 5 A

The anniversary date for attending a recertification clinic for Judges who can't recertify by CEC points will be three years from the date of the last clinic they successfully completed or instructed. Apprentices must recertify three years from their beginning clinic. The clinic must be completed by the end of that calendar year.

Approved by BOD.

Page 136 Section 5 C-1,2,3

- **C-1** An instructor must be a member in good standing, a licensed Llama or Alpaca Judge and have prior teaching experience. To be placed on the recommendation list, an Instructor must first successfully complete at least two (2) approved ALSA Judging Clinics as an Assistant Instructor with a favorable evaluation from the Instructor with a favorable evaluation from the Instructor. All instruction materials must be approved by the Judges Committee.
- **C-2** An Assistant Instructor must be a member in good standing, a licensed Llama or Alpaca Judge, and have prior teaching experience, or have completed at least one (1) apprenticeship at an approved ALSA Judging or Show Clinic with favorable evaluation form the instructor.
- **C-3** Assistant instructors may be accepted at approved ALSA judging and/or show clinics. An Apprentice Instructor must be a member in good standing and a licensed Llama or Alpaca Judge.

BOD approved Page 136 Section 5, C-1,2,3 with the wording instructor experience in place of teaching experience.

Page 137 Section 5 E

Each Judges' Clinic will be taught according to guidelines as approved and developed by the Judges' Committee. Participants at an Advanced Judging Clinic will be given a numerical score on the following clinic activities:

- 1. Terminology
- 2. Test
- 3. Conformation (Identification)
- 4. Conformation (Knowledge)
- 5.Performance classes judged
- 6. Showmanship classes judged
- 7. Halter classes judged
- 8. Fiber classes judged
- 9. Reasons (oral presentations)

3. Clinic Instructors

This is who we would like to start with. As everyone starts to sign up for the Unzicker Clinic and we get closer, if we need another instructor we can add them at that time.

Instructor

BOD asked for clarification on list of instructors.

4. Mentor Program

Mentor, - the purpose to provide remedial education to judges that did not meet the minimum requirements to recertify at the clinic.

Mentor/mentee confidential agreement

Mentee has the option to go to the next clinic to get recertified or select a mentor to recertify with. Mentor must be off the instructor list.

- 1. Instructor judge as near to mentee as possible if in alpaca or llama halter/fleece but can mentor thru email if performance with chair of ic cceed in.
- Mentor needs to know all weaknesses from the clinic and show evaluation.
- 3. Mentoring can be on the farm . show . depending on the situation. Mentor instructors will receive recert credits and also a stipend of \$175.00 per day which will be paid by the mentee just like going to a clinic.
- 4. Length of time one year of next clinic.
- 5. Mentee must pass the section of the clinic that was deficient either with instructor or at the clinic.
- 6. Instruction will not take place when the mentee of mentor is actively judging.

This gives the mentee the choice to go on, quiet, and to decide if he/she wants to attend a clinic or do one on one. Either way it will cost the mentee a fee and that is why it is less than a clinic.

In regards to Mentorship for two judges based on 2010 clinic recommendations:

As per the ALSA BOD response in the November 20th 2008 minutes to a proposal by the Show Management Committee dated November 9, 2008 any changes to rules dated after January 1st of any given year will take effect on January 1st of the following year. Due to this rule being in effect the recommendation to implement a Mentoring program prior to the end of 2010 falls outside of this guideline.

It is therefore the recommendation of the Judge's Committee that said Mentor rule take effect on January 1st of 2011.

Due to this it places in limbo the needs of the two judges who were recommended for mentoring. It is further recommended by the Judge's Committee that said two judges be placed as judges pending their required attendance at the clinic set for March of 2011. At that time the clinic instructor will be advised of their needs and asked to thoroughly evaluate them.

As an additional recommendation based on the boards approval of expenses being paid by ALSA for a mentor it is suggested that the clinic fees be waived for the two judges being required to attend above mentioned clinic.

Bob motioned to approve item 4 of the Mentor Program. Tom seconded. A roll call vote was taken: Allen-no; Bob-yes; Tom-yes; Trish-no; Keith-yes; 4 yes, 2 no; motion carried.

To the ALSA BOD

First let me apologize for the lengthy introduction, but I feel this intro is necessary to understand our proposed rule.

The permission to show rule (PTS) as it is currently written in the handbook is not explicit. Therefore to understand the PTS rule we must first understand the meaning of the rule on page 150 Sec. 4 item A. The exhibitor, owner and handler are not interchangeable terms in all cases, reference page 11 sec. 1 item C. Instead of the PTS rule stating exhibitor it should state exhibitor/owner must be the registered owner. This is not the same reference as exhibitor/handler. Owners are allowed under current guide lines to use a handler in halter classes without obtaining a PTS form, reference page 12 sec. L. Section L should read exhibitor/owner not just exhibitor.

Currently youth do not need to own an animal, Reference page 113 sec. 2 item B-2, that they show in youth classes. Llamas maybe loaned, there is no reference to youth actually having to own the animal. In this case a youth will be considered an exhibitor/handler plus an exhibitor/youth. In either case a PTS is not required as previously stated.

So the issue that needs to be conveyed in the writing of the revised rule pertaining to PTS is that there is a difference in the usage regarding the terms, exhibitor/owner, exhibitor/handler and exhibitor/youth, I will attempt to write the PTS rule to clarify these cases.

Page 11 Section 1 Item C.

C. Owner/Exhibitors must be the registered owners and make the entry in the exact names (owner and animal) as shown on the registration certificate. Exhibitor/owners may use a Permission to show form provided by ALSA which grants permission from the owner named on the registration certificate to a person who is using an animal to show under their name. Exceptions; Owners may use a handler to exhibit their animal, ie a youth handler in halter. Youth are not required to own the animal that they show in youth performance classes. 4-H, FFA, and site rules will take precedence over ALSA rules and guidelines regarding permission to show. A permission to show form is required to exhibit a fiber from an animal not owned by the exhibitor.

This proposal should satisfy the requirements regarding permission to show. The SMC believes this revision will maintain the accountability of our show organization and clarify the needs and use of the permission to show form. Thank you for your consideration and any comments or concerns may be directed to me Chair of the SMC Bill Schultz
