DIRECTIONS ... Linn Co. Fair & Expo Center: 3700 Knox Butte Road, Albany OR. Exit #234 off I-5 at Albany. Show will be in Cascade Livestock Pavilion.

HEALTH REQUIREMENTS ... animals from outside Oregon need a vet certificate issued within 30 days of the show.

REGISTRATION ... will take place between the hours of 10:00 a.m. until 10:00 p.m. on Friday October 3rd. Halter animals may arrive on Saturday October 4th or Sunday October 5th.

STALLS ... are 10' X 10' with an asphalt floor (no shredded paper bedding allowed) in the Pavilion. Stalls will be assigned. All animals must be stalled. All stalls should be vacated Sunday, October 5th, by midnight or make arrangements with the superintendent to stay Sunday night. **BRING YOUR BEDDING.**

WATER ... Is available in close proximity to stalls.

ARRIVAL ... Preferred arrival time for performance exhibitors is 10:00 a.m. until 10:00 p.m. Friday October 3rd. There is space in front of each stall for displays. Animals will be stalled after check-in at Registration. Halter animals may arrive on Saturday October 4th or Sunday October 5th.

GROOMING ... Grooming and washing facilities are available near the stall area. Please clean up after each use.

PARKING ... There is ample parking available near the Pavilion.

RULES AND GUIDELINES ... All rules and guidelines will be in accordance with the current ALSA Handbook and addenda.

AWARDS ... ALSA ribbons will be awarded 1-5th place in each class. Additional special awards supported by sponsors may be presented.

BEING LATE ... Exhibitors are urged to be prompt for their classes during the show. Once the class has entered the ring, late exhibitors may not enter the class unless the judge grants approval

ALSA POINTS ... Double Points will be awarded.

CLASS LIST... A list of classes is posted with the general information for all regional shows. Take care in choosing the correct class number for which you have qualified and are entering.

FOOD AND BEVERAGES ... Lamas: bring their own hay and a water container. People: Food vendors or complimentary snacks will be available on Saturday and Sunday.

HOUSEKEEPING ... Exhibitors are asked to cooperate in keeping the facility and stall area clean. Please be careful to deposit trash and manure in areas designated for that purpose. .

ENTRY FORM ... Please fill out and mail with your check. Animals entered in an incorrect class may not be changed to another class after the deadline without approval of the Superintendent. Call if you have any questions about entering.

DEADLINE ... Animals, which qualify in shows after September 26th, may register by calling Glen Pfefferkorn 503-437-4787.

SMOKING ... Is not permitted in the arena or stall areas.

JUDGE ... Is Patti Fischer.

EXHIBITOR MEETING ... There will be an Exhibitor Meeting for Performance Classes on Saturday, October 4th at 8:00 a.m. in the arena. Halter Exhibitor meeting will be Sunday October 5th at 8:00 am.

REGISTRATION PAPERS ... Llamas and alpacas (except non-breeders and performance and youth class entries) must be registered with the ILR or ARI. See ALSA Handbook for rules. Copies of registration certificates must be sent with your entry.

DEPARTURE ... We encourage all exhibitors to stay throughout the show, but you are not required to remain until the show is over. All stalls should be vacated by midnight Sunday October 5th.
